Let's just get right to it so that you can get back to reading and thinking and writing. A quick head's up on formatting conventions: "Quotes Are Used for Short Story Titles (and Poems and Essays)." Italics are Used for Titles of Books, Newspapers, Magazines. In-Text Citation For in-text citations, the convention is that you just include the page number for your primary source. If there's any chance of confusion, include the author's name in a phrase before the quote itself. Sammy's turn from hormone charged teen to independent citizen is signaled by a remarkably low-key sentence. As he responds to Lengel's question about ringing up the girls, the story reads "I though and said 'No' but that wasn't what I was thinking" (167). Note that the quotation marks in the original primary source were changed to single quotes. Twain makes clear that Huck rejects domesticity by his fear of being "sivilize[d]" at the end of the novel (293). Basic MLA Rules All citations should be double spaced. Indent after the first line of each entry (hanging indent) Entries are not numbered; Alphabetize by the first word of the entry. If no author is listed, begin with title. What is the difference between MLA and APA in-text citations? Both APA and MLA cite sources within a paper by using parenthetical, in-text references. MLA uses the author's last name and the page number as reference. APA uses the author's last name and the year of publication. If a direct quote is used, APA requires author's name, year, and page number. How do you end an in text citation?
